BY-LAWS OF THE DELCO INVITATIONAL DART LEAGUE

MEMBERSHIP

Sponsors and teams are to be invited to join the League. To be accepted, they must be approved by the Representative Council. Once a sponsor has been permitted to field a team in the D.I.D.L. he will always have that slot unless he chooses to relinquish it. All sponsors must have a legal liquor license.

EXECUTIVE BOARD

Shall consist of the President, Vice-President, 2ND Vice President, Secretary and Treasurer.

DUTIES

President -Preside over meetings, interpret rules, and appoints committees.

Vice-President -Assist President, take charge in his absence, and run tournaments.

Second Vice-President -Is the Chairman of the Dart Board Committee and reports to the President. Assists the President and Vice President, take charge in their absence. Assist the Vice President in running dart tournaments.

Secretary -Maintain standing sheets, average sheets, and keeps minutes.

Treasurer -Handles all League finances, submits treasurer report each captain's meeting. Turn over all financial statements within 2

weeks after DIDL banquet-to the President, Vice President and Secretary for auditing for the past year.

Elected Trustees -(3) Monitor and review all financial business of the D.I.D.L. on a monthly basis prior to the start of the monthly dart meeting

ELECTIONS AND TERMS OF OFFICE

Elections to be held at the March meeting. The term of office is to be one year. To hold any office you must have been rostered for a minimum of five years in the D.I.D.L

REPRESENTATIVE COUNCIL

Consist of the Executive Board, team captains and sponsors. Meetings to be held monthly on the first Monday unless the Executive Board waives a meeting due to insufficient business.

SALARIES

Any salaries to be paid to a league official will be derived solely from Roster Fees.

CATERING

Supplying food to shooters is at the discretion of each sponsor. Sponsors should use good judgment in this matter to assure each team equal treatment at different taverns.

FEES: ALL LEAGUE FEES ARE TO BE PAID BY CHECK ONLY

Initiation Fee -\$150.00 per sponsor; payable to allow the league to purchase and maintain equipment needed to run the League. If a sponsor's team folds during the dart season, that sponsor must pay an additional initiation fee of \$150.00 to re-enter that team into the league

Entry Fee -\$150.00 per team, per year; all money to be used for

awards and banquet

Home Game Fees -\$15.00 per home game; all money to be used for awards and banquets and a minimal amount used for league supplies

FINANCIAL TRANSACTIONS

All checks written by the D.I.D.L. require the signatures of (3) three D.I.D.L. officers to be valid. Those officers shall be: The Treasurer, President, and League Secretary.

RULE CHANGES

Rule changes require a 2/3 majority of the Representative Council present at a meeting. One month notice must be given before any rule change may be voted on. Any other voting matter will be decided by a simple majority of the Representative Council.
